

Pursuant to due call and notice there of the Southside Township Board of Supervisors met for the regular August meeting on Tuesday, August 01, 2017 at 7:00 p.m. at Southside Town hall, Wright County, MN. The following members were present: Chairman Tim Hable, Supervisors Tim Hable and John Reynolds and Clerk/Treasurer Carmen Merrill. Also present: Lonnie Hendricks, Jeremy Kaskinen and Dean Croat.

Chairman Hable led the Pledge of Allegiance.

Supv Hallstrom made a motion to approve the minutes of the July 5, 2017 regular meeting with a second by Supv Hable. Motion carried.

No one was present for the public forum.

Dean Croat was present as a representative for Greg Gerulis, 14860 62nd St NW. Dean presented a plan for removal of rail road ties and wooden sidewalk along the lake as well as the installation of rain gardens and vegetation. It was unclear if the culvert was to be removed or remain. Impervious surface coverage numbers were not available. The request to build a 780 sf garage is in the plans but Dean was not sure about the placement of the garage on the site. The Board asked Dean to get clarification regarding the culvert, impervious surface coverage and placement of the garage on the lot. Also, a site plan with the location of the garage and new additions including setbacks from lake, side lot lines and the road need to be presented. Action on the variance request was tabled to the September 12th meeting.

No one was present for the Holmberg, 7809 Pleason Ave NW, variance request so no action was taken.

Chairman Hable is meeting with a beaver trapper to review the culvert along 68th St. NW that was plugged with branches to see if trapping is a possible remedy.
