

Pursuant to due call and notice there of the Southside Township Board of Supervisors met for a regular meeting on Tuesday, September 11, 2018 at 7:00 p.m. at Southside town hall, Wright County, Minnesota. The following members were present: Chairman Jim Hallstrom, Supervisors John Reynolds and Tim Hable and Clerk/Treasurer Carmen Merrill. Also present: David & Rachel Low, John Wozniak, Phyllis Latour, Lonnie Hendricks, Jeremy Kaskinen.

Chairman Hallstrom led the pledge of allegiance.

Supervisor Hable made a motion to approve the minutes of the August 7, 2018 meeting. Supervisor Reynolds seconded the motion. Motion carried.

John Wozniak spoke during the open forum about a neighboring property with old cars, lawn mowers and debris in the backyard. Clerk Merrill was instructed to send a letter to the property owner.

Chairman Hallstrom reported he had a meeting with Luke Johnson of Wright Soil and Water Conservation District to discuss the water issue along 100<sup>th</sup> St NW and Norton Ave NW. Luke had plans that had been drawn up by their engineer with included plans for changing the 24” culvert under 100<sup>th</sup> St NW to an 18” culvert, adding 200’ of 12” pipe leading north to the basin at the bottom of the ravine on Norton Ave NW. The area south of 100<sup>th</sup> St NW had not been included in any of the plans but Luke will have the engineer include the ditch work and holding basin on the south side of 100<sup>th</sup> in the plans as well as other changes discussed. Luke had indicated there was a Community Partnership Grant available for the work. No solid numbers for the cost of the work were presented. Chairman Hallstrom will ask Luke to come to the October meeting with the revised plans.

David and Rachel Lowe, 7836 Norris Ave NW, were present to discuss the possibility of trenching under or through Norris Ave NW to get electrical service to his new shed on the back lot. Chairman Hallstrom stated the Board would prefer underground boring for the electrical to retain the integrity of Norris Ave NW. If trenching through the road is the only alternative the road would have to be returned to its original condition. David will review his options and let the township know how they plan to get electrical to their shed – underground or trenching. The Board will review at the October meeting.

Jeremy Kaskinen reported he will be trimming trees along 109<sup>th</sup> St NW to allow Mike Merten to move his rambler in to the foundation. Jeremy stated the road was slated for trimming by the township next year but he could do it this fall to allow for the house mover. The Board was agreeable with the trimming this fall.
