Supervisor Hable made a motion to approve the appointments for 2021 with a second by Supervisor Hallstrom. Motion carried.

Steve and Greg Alberg, 217-000-241100, & 217-000-241401-8518 Montgomery Ave NW, requests a variance to allow approximately 8.2 acres to be added to the existing 2.2 acre "entitlement" lot with an existing house that will not have the minimum 300' wide along Pleasant Lake. Reason a variance is needed is 1 per 40 entitlement divisions are limited to a maximum of 10 acres and must meet minimum lot standards. A minimum of 300' wide on the lakeside is required. The 8.2-acre lot has approximately 190 ft of lakeshore on Pleasant Lake. The 33.7-acre lot will be divided into 3 lots – Lot 1 will be 10.6 acres; Lot 2 will be 14.9 acres and Lot 3 will be 8.2 acres and will be added to 217-01010-241401 lot owned by Greg and Steve's sister. She has lived in her house on the 2.2-acre parcel since it was built in 1997. Their mother has passed, and they would like to divide up this parcel and allow their sister to keep the piece of land that gives her access to the lake. The other two lots will be sold for development. They will require a shared driveway at a location to be determined. Due to the lay of the road the County had noted the field road was in an area that had limited

visibility. They are requesting rezoning of the land from Ag to Rural residential so that the two lots can get a building entitlement. The land is wooded and would make a beautiful building site. Supervisor Hallstrom made a motion to approve the zoning from Ag to Rural Residential with a second by Supervisor Ferguson due to the land being wooded and near more dense housing area. Motion carried.

The Board discussed the 300' minimum lot size for the 8.2 acre parcel. The land has been in the family for decades and the family has used this access for the lake. The remaining lots do not have lake access. The lot is large and would not infringe on the neighboring lots. Supervisor Ferguson made a motion to approve for Lot 3 to be approved with the 190' lakeshore due to the size of the lot. Supervisor Hable seconded the motion. Motion carried.
