Pursuant to due call and notice there of the Southside Township Board of Supervisors met for their regular meeting on Tuesday, October 4, 2022 at 7:00 p.m. at Southside Township hall. The following members were present: Chairman Marty Ferguson, Supervisors Tim Hable and Jim Hallstrom and Clerk/Treasurer Carmen Merrill. Also present: Bernie Miller and Duane Sparks.

Chairman Ferguson led the Pledge of Allegiance.

Supervisor Hable made a motion to approve the minutes of the September 6, 2022, regular meeting. Supervisor Hallstrom seconded the motion. Motion carried.

Clerk Merrill reported the Montgomery Ave and 80th St overlay project is moving along. Milling started on September 28 and the overlay should be done this week.

Duane Sparks and Bernie Miller, 6769 Pilger Ave NW, were present to request a variance to allow the construction of an addition to an existing home that is inside of the shoreland building setback and setback from the bluff. The proposed addition is on a nonconforming home that is within the 75' setback by 2' on one corner and 7' on another corner. Duane explained he came for a variance to build a new home on the lot next to this home. He and his wife wanted to build a new home to eliminate the stairs. Once the plans were approved his wife had a change of heart. She couldn't leave the home they raised their family in and entertained their now grown grandchildren. So they hired a architect and came up with a way to improve the existing home. They are connecting the addition to the lowest level. The entire additions will be within the 75' setback and have no impact to the bluff. Total proposed coverage is 2.9%. Supervisor Hable made a motion to approve the variance request with a second by Supervisor Hallstrom. Motion carried.

The Board reviewed the hourly mowing fee for cemetery and township hall. The rate has not been changed for 4 years. With the cost of gas it is time for an adjustment. Motion by Supervisor Ferguson with a second by Supervisor Hallstrom to change the rate for mowing to \$25/hour.

Motion by Chairman Ferguson to appoint Kim Sawatzke as a election judge and move Meggan Caird to Head Election judge for the General Election. Supervisor Hallstrom seconded the motion.
